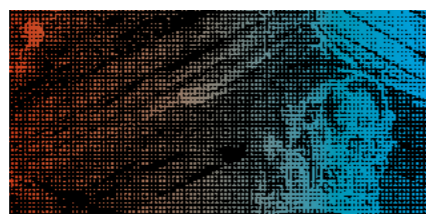

Throughout their academic journey, students will be immersed in a highly stimulating environment in which their enquiry-based learning experience will be nurtured not only by lectures with top academics but also by testimonials from highly reputed professionals, mainly from the network of Luiss Alumni, laboratories, project works, simulations and legal clinics that will culminate in a “Grand Challenge”. Highly interdisciplinary, the Programme provides a strong foundation in the legal field while also developing a deep understanding of economics, management, and technological innovation. The curriculum is further enriched by a Humanities course of the student’s choosing. In the third year, students have the option to specialise in two areas: Global Law and Tech, or Global Law and Business. There is also a third choice in Italian Law, which provides access to the final two years of the traditional Italian legal studies degree programme.

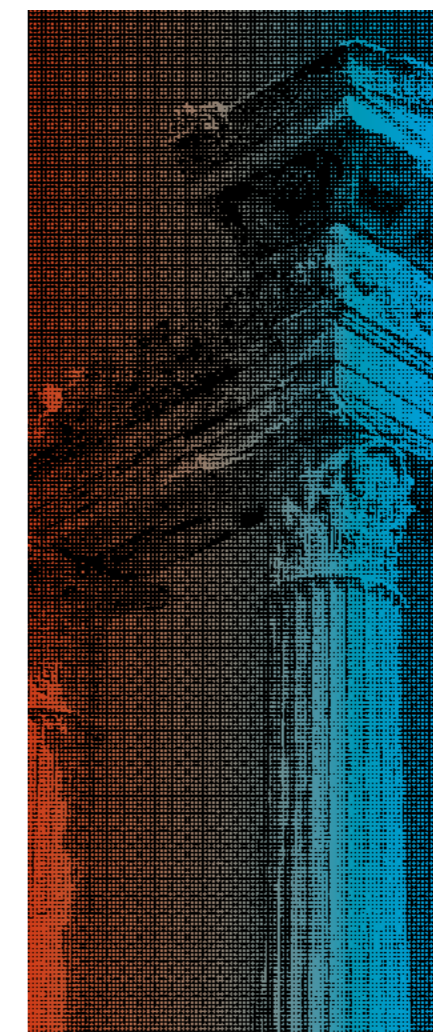
